What are the rules about fundraising and relation to school? Principals can do their own fundraising with their own school activities fund but they must disclose how much and where it will go within 5 days. We recommend that the Home and School work with school staff to decide which fundraising will be done by which organization.

Are we a “legitimate” organization when donors ask us? By “legitimate” they want to know if you are a tax exempt 501c3 charitable nonprofit. Currently, the central organization is covered as a 501c3 but each of the individual home and schools is not. We are working on getting that done in the coming months.
